## Required Safety Equipment

It is the responsibility of all anglers to have required state and federal safety equipment on board. At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throw able PFD; and demonstrate functioning kill switch.

KS state law requires that NO water may be transported away from the lake in a boat or container of any kind this INCLUDES bait wells. All drain plugs and water must be drained/removed before leaving the ramp area every day. By law, any live bait fish you have in your possession you MUST have a receipt of purchase with them from a retail bait supplier in the state of Kansas. Buy ONLY enough for each day as no water can be taken from the lake and transported back to hotels or anywhere, this includes bait wells. Bait FISH only does not apply to leeches or crawlers.
