**20. PARTICIPANT RELEASE OF LIABILITY – READ BEFORE SIGNING**

I KNOWINGLY AND FREELY ASSUME ALL RISKS referred to above, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE WALLEYE FEDERATION and/or MASTERS WALLEYE CIRCUIT, THEIR OFFICERS, OFFICIALS, DIRECTORS, SHAREHOLDERS, AGENTS, AND/OR EMPLOYEES, OTHER PARTICIPANTS, AND SPONSORING AGENCIES, SPONSORS, ADVERTISERS, TOURNAMENT OFFICIALS AND VOLUNTEERS AND, IF APPLICABLE, OWNERS AND LESSORS OF PREMISES AND PROPERTY used to conduct the event (“RELEASEES”) OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR RISKS ARISING FROM MY PARTICIPATION; AND,

I willingly agree to comply with the terms and conditions for participation. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the immediate attention of the nearest official; and,

I agree to submit, by signature on this document, to a polygraph or voice stress analysis examination. Hereinafter known as truth verification test, and abide by its conclusion. Truth verification test(s) will be used at TWF's sole discretion, and administered by TWF or its agents. I understand that failure to pass the examination as determined by TWF will result in disqualification. I certify that the number shown on these forms is my correct taxpayer identification number.
