<p><u>Location:</u> Community REC Center 2501 Pierce Ave Marinette, WI 54143</p> <p><u>Date:</u> Wednesday May 31, 2023</p> <p><u>Registration Times:</u> 4:00 p.m. – Registration Opens 6:00 p.m. – Registration Closes. 6:15 p.m. – Mandatory rules briefing begins.</p> <p>All anglers must be off the water by 4:00 p.m. on the day of the rules meeting.</p>	<p>Menekaunee Harbor 828 Ogden ST Marinette, WI 54143 (Please see the attached map for launch sites.)</p> <p>Take-off will begin at 7:00 a.m. or first safe light.</p> <p>Weigh-In begins at 3:00 p.m.</p>	<p>It is the responsibility of all anglers to have required state and federal safety equipment on board.</p> <p>At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies.</p>
<p><u>Fish Limits</u></p> <p>Fish size: 15 inches and over.</p> <p>Teams are allowed to weigh a limit of five (5) fish per team, per day. No more than seven (7) fish in the live well. Release any fish not being weighed prior to making your final run in. <u>Culling is not allowed.</u></p> <p>Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8-ounce deduction will be made for each fish presented to the bump master for weighing that is determined to be non-releasable.</p>	<p><u>Site Host</u></p> <p>Marinette City 1905 Hall Ave Marinette, WI 54143 https://www.marinette.wi.us/</p> <p>Country Inn and Suites - 2020 Old Peshtigo Ct, Marinette, WI 54143 (715) 732-3400</p> <p>Best Western Riverfront Inn - 1821 Riverside Ave, Marinette, WI 54143 (715) 732-1000</p>	<p><u>Boundaries</u></p> <p>The tournament waters for this event shall be Bay of Green Bay and shall include all rivers, creeks and canals connecting to the above-mentioned waters. Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p> <p>Michigan waters are OPEN south of a line drawn from the mouth of the Bark River to Peninsula Point Lighthouse.</p>
