Weigh-In begins at 2:00 p.m. Anglers may use any ramp they wish to unload/load their boat. | It is the responsibility of all anglers to have required state and federal safety equipment on board. At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch. Inspection will be held during lineup for takeoff. Live wells must be empty. Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies. |
| Fish Limits | Site Host | Boundaries |
| Fish size: 15 inches and over. Walleye, Sauger/Saugeye Teams are allowed to weigh a limit of five (5) fish per team, per day. Each angler is allowed one (1) fish 20" and over. When the 8th fish goes into your livewell you are done fishing for the day. Culling is not allowed. Any live release areas established by the Tournament director will be off limits. That as well as any additional off limits will be announced at the pretournament briefing. Only water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply. |
